3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY TO (I)
5 SUBMIT AN APPLICATION TO THE CALIFORNIA STATE
6 DEPARTMENT OF HOUSING AND COMMUNITY
7 DEVELOPMENT FOR FUNDING UNDER THE TRANSIT-
8 ORIENTED DEVELOPMENT (TOD) HOUSING PROGRAM;
9 AND (II) EXECUTE ALL DOCUMENTS NECESSARY TO
10 PARTICIPATE IN THE TOD HOUSING PROGRAM IF
11 SELECTED FOR SUCH FUNDING.

13 WHEREAS, the City of Long Beach ("City"), a political subdivision of the
14 State of California, wishes to apply for and receive an allocation of funds through the
15 TOD Housing Program (the "TOD Program"); and

16 WHEREAS, the California Department of Housing and Community
17 Development ("HCD") has issued a Notice of Funding Availability ("NOFA") for the TOD
18 Program established under the Housing and Emergency Shelter Trust Fund Act of 2006
19 (Proposition 1C) pursuant to the TOD Implementation Program established by Part 13 of
20 Division 31 of the Health & Safety Code, commencing with Section 53560. Pursuant to
21 the statute, HCD is authorized to approve funding allocations utilizing monies made
22 available by the State Legislature to the TOD Program, subject to the terms and
23 conditions of the statute and the TOD Program Guidelines implemented as amended by
24 HCD on 12/03/2007; and

25 WHEREAS, City wishes to submit an application to obtain from HCD an
26 allocation of TOD Program funds in an amount up to \$17,000,000.

27 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
28 follows:

1 Sec. 1. The City shall submit to HCD an application to participate in the
2 TOD Program in response to the NOFA issued on December 11, 2007 which will request
3 a funding allocation in the amount of up to \$17,000,000 for (i) the construction of rental
4 units, (ii) the construction of capital improvements, and the (iii) the funding of loans to
5 qualified first time homebuyers, each in connection with a project located at 1235 Long
6 Beach Boulevard (corner of Long Beach Boulevard and Anaheim Street).

7 Sec. 2. If the application for funding is approved, the City hereby agrees to
8 use the TOD Program funds for eligible activities in the manner presented in the
9 application as approved by HCD and in accordance with the program Guidelines cited
10 above. It also may execute any and all other instruments necessary or required by HCD
11 for participation in the TOD Program.

12 Sec. 3. The City Manager is authorized to execute in the name of the City,
13 the application, the Standard Agreement, and all other documents required by HCD for
14 participation in the TOD Program, and any amendments thereto.

15 Sec. 4. This resolution shall take effect immediately upon its adoption by
16 the City Council, and the City Clerk shall certify the vote adopting this resolution.
