THIRTY-THIRD AMENDMENT TO AGREEMENT NO. 23214

**23214**

THIS THIRTY-THIRD AMENDMENT TO AGREEMENT NO. 23214 is made and entered, in duplicate, as of January 21, 2020, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on February 6, 2018, by and between TRITECH SOFTWARE SYSTEMS, a California corporation, formerly known as TIBURON, INC. ("Tiburon"), a Virginia corporation, formerly known as COMPUDYNE-PUBLIC SAFETY & JUSTICE, INC., with a place of business at 1000 Business Center Drive, Lake Mary, Florida 32746 and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Tiburon (the "Parties") entered into Agreement No. 23214 whereby Tiburon agreed to provide specialized data processing services to Computer Aided Dispatch ("CAD") and Record Management Systems for City's Police and Fire Departments ("Project") and to grant a license and maintenance for the Project; and

WHEREAS, the Parties have entered into thirty-two amendments to Agreement No. 23214; and

WHEREAS, the Parties desire to amend the Agreement to extend the term one (1) additional one-year period and add \$489,844.22 to the extension, for a total not to exceed Contract amount of \$2,633,814.22;

NOW, THEREFORE, in consideration of the mutual terms, covenants and conditions in Agreement No. 23214 and herein contained, the Parties agree as follows:

1. TriTech Software Systems ("TriTech"), through purchase, currently owns all of the assets of Tiburon, including all rights, title, and interest in the CAD and Project. Each Party mutually consents to TriTech's substitution as the Party obligated to perform under Agreement No. 23214; and agrees to be bound by all terms and conditions previously entered into the Agreement No. 23214 between City and Tiburon. All references to the name "Tiburon" as used in Agreement No. 23214 shall mean and be construed as reference to "TriTech".

1                   2.     The term for support and maintenance of the Computer-Aided  
2 Dispatch Software and Records Management System is hereby extended beginning on  
3 March 1, 2020 and ending on February 28, 2021.

4                   3.     Notwithstanding anything to the contrary in the Agreement, previous  
5 amendments, attachments or exhibits, Tiburon shall provide software support services for  
6 an additional twelve-month term through February 28, 2021, and City shall pay for these  
7 services during the extension an amount not to exceed Four Hundred Eighty-Nine  
8 Thousand Eight Hundred Forty-Four Dollars and Twenty-Two Cents (\$489,844.22), for a  
9 total not to exceed Contract amount of Two Million Six Hundred Thirty-Three Thousand  
10 Eight Hundred Fourteen Dollars and Twenty-Two Cents (\$2,633,814.22).


11                  4.     Except as expressly amended in this Thirty-Third Amendment, all


