WHEREAS, the parties entered into Agreement No. 34080 on November 10, 2015 ("Agreement"), wherein Contractor agreed to perform hazardous abatement work to the Old Courthouse Building;

WHEREAS, in connection with the City's authorization to demolish the Old Courthouse Building, the parties wish to increase the scope of work under the Agreement and to increase the authorized amount of City expenditures under the Agreement;

NOW, THEREFORE, in consideration of the mutual terms and conditions herein, the parties agree as follows:

- 1. Contractor shall furnish all necessary labor, supervision, tools, materials, supplies, appliances, equipment and transportation for all of the work described in "Project Plans and Specifications No. R-7043 for City of Long Beach Old Court House Demolition in the City of Long Beach, California," (including the base bid and all additive bid items described therein) said work to be performed according to the Contract Documents identified below. However, this Contract is intended to provide to City complete and finished work and, to that end, Contractor shall do everything necessary to complete the work, whether or not specifically described in the Contract Documents.
- 2. City shall pay to Contractor the amount(s) for materials and work attributable to all of the work (including the base bid and all additive bid items described therein) as identified in Contractor's "Bid for City of Long Beach Old Court House Demolition in the City of Long Beach, California," attached to the Agreement as Exhibit "A".

3. The Time for Contrac	ct described in Section 4 of the Agreement is

before May 31, 2016.
