## FIRST AMENDMENT TO CONTRACT NO. 33312

THIS FIRST AMENDMENT TO CONTRACT NO. 33312 is made and entered, in duplicate, as of November 5, 2013 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on July 1, 2014, by and between K & H PRINTERS-LITHOGRAPHERS, INCORPORATED, a Washington corporation ("Consultant"), with a place of business at 7720 Hardeson Road, Everett, Washington 98203, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with mailing services and printing of official ballots, sample ballots and vote-by-mail materials ("Project"); and

WHEREAS, City selected Consultant in accordance with City's administrative procedures and City determined that Consultant and its employees are qualified, licensed, if so required, and experienced in performing these specialized services; and

WHEREAS, due to an eighteen percent (18%) increase in the number of voter registrations for the 2014 elections over the 2012 number of voter registrations, City desires to amend this Agreement for mailing and printing services of official ballots, sample ballots and vote by mail materials in an increased amount not to exceed Three Hundred Six Thousand Six Hundred Ninety-Two Dollars and Fifty-Seven Cents (\$306,692.57);

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in this Agreement, the parties agree as follows:

- 1. Section 1.A of Contract No. 33312 is hereby amended to read as follows:
  - "1. SCOPE OF WORK OR SERVICES.
    - A. Consultant shall furnish specialized services more particularly

described in Exhibit "A-1", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Nine Hundred Twenty Three Thousand Fifty-Nine Dollars and Fifty-Seven Cents (\$923,059.57 at the rates or charges shown in Exhibit "B"."

2. The Scope of Work provided under the Contract is hereby amended as more particularly described in Exhibit "A-1", attached hereto and incorporated by this reference.
