3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO APPLY FOR A USED OIL PAYMENT
6 PROGRAM APPLICATION AND RELATED
7 AUTHORIZATIONS, EFFECTIVE UNTIL RESCINDED

9 WHEREAS, pursuant to Public Resources Code § 48690, the Department
10 of Resources Recycling and Recovery (CalRecycle), formerly known as the California
11 Integrated Waste Management Board, has established the Used Oil Payment Program
12 (OPP) to make payments to qualifying jurisdictions for implementation of their used oil
13 programs; and

14 WHEREAS, in furtherance of this authority CalRecycle is required to
15 establish procedures governing the administration of the Used Oil Payment Program; and

16 WHEREAS, CalRecycle's procedures for administering the Used Oil
17 Payment Program require, among other things, an applicant's governing body to declare
18 by resolution certain authorizations related to the administration of the Used Oil Payment
19 Program;

20 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
21 follows:

22 Section 1. The City Council authorizes the submittal of a Used Oil
23 Payment Program application to CalRecycle.

24 Section 2. The City Manager or his designee is hereby authorized and
25 empowered to execute in the name of the City of Long Beach all documents, including
26 but not limited to, applications, agreements, annual reports including expenditure reports
27 and amendments necessary to secure said payments to support the Used Oil Collection
28 Program. This authorization is effective until rescinded.
