

1 FIRST AMENDMENT TO AGREEMENT NO. 30629

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 30629 is made and
4 entered, in duplicate, as of March 10, 2010 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting held on
6 March 9, 2010, by and between KLEINFELDER WEST, INC., a California corporation,
7 with a place of business at 5015 Shoreham Place, San Diego, California 92122
8 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the parties entered Agreement No. 30629 whereby Consultant
10 agreed to perform As-Needed Materials Testing and Inspection, and Construction
11 Management Services for Public Works Infrastructure and Facility Projects; and

12 WHEREAS, the parties desire to increase the Agreement amount by
13 \$1,750,000;

14 NOW, THEREFORE, in consideration of the mutual terms and conditions in
15 the Agreement and in this First Amendment, the parties agree as follows:

16 1. Section 1.A. of Agreement No. 30629 is hereby amended to read as
17 follows:

18 "1. SCOPE OF WORK OR SERVICES.

19 A. Consultant shall furnish specialized services more particularly set
20 forth in Exhibit "A", attached hereto and incorporated herein by this reference, in
21 accordance with the standards of the profession, and City shall pay for said services in
22 the manner described below, not to exceed \$3,500,000.00, at the rates or charges
23 described in Exhibit "A".

24 2. Except as expressly amended in this First Amendment, all terms and
25 conditions in Agreement No. 30629 are ratified and confirmed and shall remain in full
26 force and effect.
