3 AN ORDINANCE OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AMENDING THE LONG BEACH
5 MUNICIPAL CODE BY AMENDING SUBSECTION A OF
6 SECTION 16.04.030 AND BY ADDING SUBSECTIONS I
7 THROUGH N TO SECTION 16.04.040, ALL RELATING TO
8 BELMONT VETERANS' MEMORIAL PIER

10 The City Council of the City of Long Beach ordains as follows:
11

12 Section 1. Subsection A of Section 16.04.030 of the Long Beach
13 Municipal Code is hereby amended to read as follows

14 A. No person shall cast, throw, or otherwise cause to be propelled
15 any fishing line from any municipal wharf or dock or pier in either an
16 overhead cast or side cast.
17

18 Section 2. Section 16.04.040 of the Long Beach Municipal Code is
19 amended by adding Subsections I, J, K, L, M, and N to read as follows:

20 I. Fish, or store fishing related gear or personal belongings, in any
21 area of the Belmont Veterans' Memorial Pier except as identified as a
22 "Fishing Area" on the Belmont Veterans' Memorial Pier.

23 J. Actively utilize more than three fishing poles/lines at any time.

24 K. Cut bait or clean fish except in an appropriate fish cleaning
25 station.

26 L. Jump or dive from the Belmont Veterans' Memorial Pier, except
27 as part of a class supervised by the Long Beach Fire Department Safety
28 Division.

M. Consume alcohol except in areas designated by the City as part of a restaurant/snack facility or permitted special event.

N. Take mussels from the pilings of Belmont Veterans' Memorial Pier.


Section 3. The City Clerk shall certify to the passage of this Ordinance by the City Council and cause it to be posted in three conspicuous places in the City of Long Beach, and it shall take effect on the thirty-first day after it is approved by the Mayor.


