1 EIGHTH AMENDMENT TO AGREEMENT NO 34690

3 THIS EIGHTH AMENDMENT TO AGREEMENT NO. 34690 is made and
4 entered, in duplicate, as of June 29, 2020, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on March
6 5, 2019, by and between THE CODE GROUP, INC. DBA VCA CODE, a California
7 corporation ("Consultant"), with a place of business at 1845 West Oranewood Avenue,
8 Suite 210, Orange, California 92868, and the CITY OF LONG BEACH, a municipal
9 corporation ("City").

10 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
11 34690 (the "Agreement") whereby Consultant agreed to provide as-needed plan review
12 and inspection services; and

13 WHEREAS, the Parties entered into a First Amendment to the Agreement to
14 add \$24,800 for a total not to exceed amount of \$59,800; and

15 WHEREAS, the Parties entered into a Second Amendment to the Agreement
16 to add \$118,800 for a total not to exceed amount of \$178,600; and

17 WHEREAS, the Parties entered into a Third Amendment to the Agreement
18 to add \$75,000 for a total not to exceed amount of \$253,600; and

19 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement
20 to add \$136,900 for a total not to exceed amount of \$390,500; and

21 WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to
22 add \$55,000 for a total not to exceed amount of \$445,500 and extend the term to July 31,
23 2020; and

24 WHEREAS, the Parties entered into a Sixth Amendment to the Agreement
25 to add \$304,500 for a total not to exceed amount of \$750,000; and

26 WHEREAS, the Parties entered into a Seventh Amendment to the
27 Agreement to add \$80,000 for a total not to exceed amount of \$830,000; and

28 WHEREAS, the Parties desire to add \$200,000 to the Agreement for a total

1 not to exceed amount of \$1,030,000 and extend the term one (1) additional one-year
2 period;

3 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
4 conditions herein contained, the Parties agree as follows:

5 1. Section 1.A. of the Agreement is hereby amended to read as follows:

6 "A. Consultant shall furnish specialized services more particularly
7 described in Exhibit "A", attached to this Agreement and incorporated by this
8 reference, in accordance with the standards of the profession, and City shall pay for
9 these services in the manner described below, not to exceed One Million Thirty
10 Thousand Dollars (\$1,030,000), at the rates or charges shown in Exhibit "B"."

11 2. Section 2 of the Agreement is hereby amended to read as follows:

12 "2. TERM. The term of this Agreement shall commence at midnight on
13 August 1, 2017, and shall terminate at 11:59 p.m. on July 31, 2021, unless sooner
14 terminated as provided in this Agreement, or unless the services or the Project is
15 completed sooner."

16 3. Except as expressly amended herein, all terms and conditions in
17 Agreement No. 34690 are ratified and confirmed and shall remain in full force and effect.

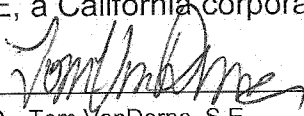

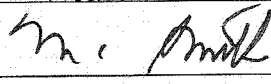

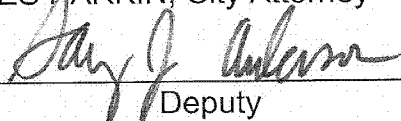
