SECOND AMENDMENT TO LIGHTING CONTRACT NO. 24289

THIS SECOND AMENDMENT is made and entered, in duplicate, as of November 15, 1996 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on November 21, 1995, by and between CITY LIGHT & POWER, INC., a Colorado corporation ("CLP"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered Contract No. 24289 whereby CLP agreed to convert the City's Street Light System; and

WHEREAS, said Contract included a provision whereby the City had an option to request that CLP also convert Other Lights, a portion of which are the City's safety lights; and

WHEREAS, the City desires to proceed with the conversion of its safety lights;

NOW, THEREFORE, in consideration of the mutual terms and conditions contained in Lighting Contract No. 24289 and herein, the parties agree as follows:

1. Section 14 is hereby added to Lighting Contract No. 24289 to read as follows:

"14. SAFETY LIGHTS

"14.1 <u>Safety Lights</u>. CLP shall convert the City's safety lights in same manner, at the same time, and as described for the Street Light System in this Contract.

"Safety lights shall mean those lights which are on top of City's traffic signal poles.

"14.2 <u>Compensation</u>. For the services relating to the safety lights, City shall pay to CLP a sum not to exceed Four

Hundred Five Thousand Nine Hundred Four Dollars (\$405,904.00).
