

**AMENDMENT NO. ONE TO CONTRACT NO. 29304**

**RE: Renewal of PA-02705, Contract No. 29304 to Furnish and Deliver Diversion of Green Waste & Tree Trimming Services for the City of Long Beach (BPLB06000003)**

This Amendment to Contract No. 29304 is made and entered as of November 1, 2006, by and between the CITY OF LONG BEACH, a municipal corporation, and EDCO Waste Services, LLC (Contractor)

Contract No. 29304 is amended by mutual agreement of the parties and as indicated below by a check or other mark preceding the appropriate amendment:

- 1. The term is extended to November 1, 2007
- 2. \$200,000 has been added to the 1<sup>st</sup> renewal term for a total ("not to exceed") amount of \$400,000.
- 3. Prices during this period shall remain firm.
- 4. The price for certain items shall be increased as shown on Exhibit "A", which is attached hereto and incorporated herein by this reference.
- 5. The price for certain items shall be decreased as shown on Exhibit "A", which is attached hereto and incorporated herein by this reference.
- 6. The discount offered to the City is increased by \_\_\_\_ %
- 7. The items or locations identified on Exhibit "B", which is attached hereto and incorporated herein by this reference, are hereby deleted from the Contract.
- 8. The locations identified on Exhibit "B", which is attached hereto and incorporated herein by this reference, are hereby added to the Contract.
- 9. Current permits, licenses, insurance and other required information are attached as Addendum No. 1.

Except as expressly amended above, all terms and conditions in this Contract are ratified and confirmed and remain in full force and effect. Executed with all formalities required by law as of the date first stated above.

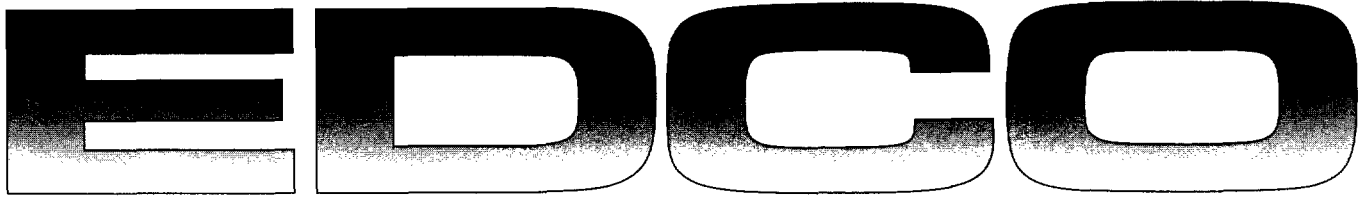

As you are aware, the term of the contract for transporting green waste debris between EDCO Waste Services and the City of Long Beach expired on November 1, 2006. In addition, the contract provides for two additional one-year options and appreciates your consideration in exercising a the first renewal option.

Unfortunately, increases in cost elements such as fuel, workers compensation, general liability insurance and other areas beyond our control have had a tremendous impact in the cost of providing hauling and recycling services of green waste materials for the City of Long Beach.

As a result, EDCO Waste Services is respectfully submitting for your consideration, a request for the City of Long Beach to allow the first option of two one-year periods, allowing for a rate adjustment of 5.1% based on the average for the ongoing 2006 year of the consumer price index for The Los Angeles-Riverside-Orange Counties as published by the U.S. Department of Labor for October 2006, of which we are here, attaching a copy for your review.
