13	F. "Car Rental Agency" means any business involving the
14	rental, leasing, or repossession or transportation of new or used vehicles
15	for rental or leasing.

17	Section 2. Section 5.16.050 as Article VI of the Long Beach Municipal
18	Code is hereby added to read as follows:
19	Article VI Car rental agencies
20	5.16.050 Use of streets prohibited.
21	No person engaged in conducting or carrying on the business of car rental
22	agency, as that term is defined in Section 5.16.010, shall store, display or park for
23	such purposes any motor vehicle in his possession or under his control upon any
24	public street or highway. This section shall not apply to any motor vehicle
25	registered in the name of such person or to any motor vehicle for which an
26	application and fee for registration in the name of such person has been filed with
27	the California Department of Motor Vehicles as long as the vehicle is not to be
28	rented or leased by the owner of the business. This section shall not apply to any

1 motor vehicle rented or leased by an individual from a rental car agency. 2 3 Section 3.
