

FIRST AMENDMENT TO CONTRACT NO. 29257

THIS FIRST AMENDMENT TO AGREEMENT NO. 29257 is made and entered, in duplicate, as of January 17, 2007 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on January 9, 2007, by and between GTSI CORP., doing business in California as GOVERNMENT TECHNOLOGY SERVICES, INC., a Delaware corporation, located at 3901 Stonecroft Boulevard, Chantilly, Virginia ("Contractor"), and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, the parties entered Contract No. 29257 to purchase electronic safety equipment; and

WHEREAS, the County of Fairfax, Virginia has an existing contract for the purchase of this equipment from Contractor, which has been designated as Contract Number RQ03-605674-16A ("Fairfax Contract"), attached as Exhibit "A" to the Agreement and incorporated by this reference; and

WHEREAS, Resolution No. RES-05-0069 authorized the City Purchasing Agent to purchase this equipment from Contractor by virtue of the Fairfax Contract; and

WHEREAS, the City desires to purchase upgraded electronic safety equipment under the Fairfax Contract;

NOW, THEREFORE, in consideration of the terms and conditions contained herein, the parties agree as follows:

1. Section 1.b. of Agreement No. 29257 is hereby amended in its entirety to read as follows:

"b. Contractor shall sell, furnish and deliver to the City equipment of substantially the same type and kind purchased by the County of Fairfax, Virginia and on the same terms and conditions offered to the County of Fairfax, Virginia, except as modified by mutual agreement between the City of Long Beach and Contractor, ordered by the City not to exceed \$2,894,877.05, plus tax. To the extent that the Fairfax Contract


1 and this Agreement are inconsistent, the following priority shall govern: (1) this Agreement
