
I was a member of the Environmental Task Force. I suggest that the first order of business for the Environmental Commission be oversight of development of an environmental management system. The U.S. EPA is currently funded such initiatives in several municipalities.

An Environmental Management System ("EMS") is that part of an overall management system developed to address environmental concerns through the allocations of resources, assignment of responsibilities and ongoing evaluation of practices, procedures and organizational processes by policy makers.

ISO stands for International Organization for Standardization which is based in Geneva, Switzerland. ISO 14001 is a voluntary, consensus-based approach that goes beyond compliance with statutes and regulations governing hazardous materials and wastes. It is not a technical standard and does not set prescribed standards of performance. It established the practices and procedures for implementing an Environmental Management System ("EMS").

The keystone of every environmental management system is systematic evaluation, which involves ongoing objective measurement and analysis of environmental performance and benefits. An EMS is developed and sustained by a cross-functional, team committed to planning, improving, measuring and communicating, environmental performance throughout all levels of operations and the community.

Long-term environmental performance is achieved by placing emphasis on participation in the process by senior level decision-makers and their commitment to the organization's Environmental Policy. The process is iterative and consists of four elements: Plan, Do, Check, Act.
