FIRST AMENDMENT TO AGREEMENT NO. 32229

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with As-Needed Certified Materials Testing and Inspection, and Construction Management Services; and

WHEREAS, the parties desire to increase the total Agreement amount by an additional \$75,000 and extend the term;

Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Five Hundred Seventy-Five Thousand Dollars (\$575,000), at the rates or charges shown in Exhibit "B"."
