1 FIRST AMENDMENT TO AGREEMENT NO. 32229

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 32229 is made and
4 entered, in duplicate, as of February 6, 2014, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 January 7, 2014, by and between GROUP DELTA CONSULTANTS, INC., a California
7 corporation ("Consultant"), with a place of business at 370 Amapola Avenue, #212,
8 Torrance, California 90501, and the CITY OF LONG BEACH, a municipal corporation
9 ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with As-Needed Certified Materials Testing and Inspection, and
12 Construction Management Services; and

13 WHEREAS, the parties entered Agreement No. 32229 whereby Consultant
14 agreed to provide these Services; and

15 WHEREAS, the parties desire to increase the total Agreement amount by
16 an additional \$75,000 and extend the term;

17 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
18 conditions herein contained, the parties agree as follows:

19 1. Section 1.A. of Agreement No. 32229 is hereby amended to read as
20 follows:

21 "1. SCOPE OF WORK OR SERVICES.

22 A. Consultant shall furnish specialized services more particularly
23 described in Exhibit "A", attached to this Agreement and incorporated by this reference,
24 in accordance with the standards of the profession, and City shall pay for these services
25 in the manner described below, not to exceed Five Hundred Seventy-Five Thousand
26 Dollars (\$575,000), at the rates or charges shown in Exhibit "B".

27 2. Section 2 of Agreement No. 32229 is hereby amended to read as
28 follows:

1 "2. TERM. The term of this Agreement shall commence at midnight on
2 January 31, 2011, and shall terminate at 11:59 p.m. on January 31, 2015, unless sooner
3 terminated as provided in this Agreement, or unless the services or the Project is
4 completed sooner."

5 3. Except as expressly modified herein, all of the terms and conditions
6 contained in Agreement No. 32229 are ratified and confirmed and shall remain in full
7 force and effect.
