Attachment 1 Continuum of Care Funding Options

Permanent Housing – Shelter Plus Care: The Shelter Plus Care Program is designed to provide permanent housing and supportive services to homeless persons with disabilities and their families. In the case of a homeless household, at least one adult member must be considered disabled. HUD pays for the housing through rental assistance payments following the same concept as Section 8 vouchering. The grantee must provide a dollar-for-dollar match to be used for supportive services.

Permanent Housing for Persons with Disabilities: Permanent Housing for Persons with Disabilities is long-term housing for the homeless and disabled population. Basically, it is community-based housing and supportive services that can be provided in one structure, several structures at one site, or multiple structures at scattered sites.

Permanent Housing – Single Room Occupancy (SRO): The SRO program is permanent housing in the form of Section 8 rental assistance working in collaboration with local public housing agencies. The rental assistance payments cover the difference between a portion of the tenant's income (normally 30 percent) and the unit's rent, which must be within the Fair Market Rent (FMR) established by HUD. Unlike the previous two permanent housing categories, SRO funds can be used for all homeless populations. Rental assistance for SRO units is provided for a period of 10 years. To be eligible for assistance, owners of SROs must invest at least \$3,000 of rehabilitation costs per unit and meet housing quality standards. Due to zoning limitations, the City of Long Beach does not apply for these funds.

Transitional Housing: Transitional Housing facilitates the movement of homeless individuals and families to permanent housing within 24 months. This temporary housing is combined with supportive services to enable homeless individuals and families to live as independently as possible.

Safe Havens: A Safe Haven is a form of supportive housing in which a structure, or a clearly defined portion of a structure, or scattered site housing, which are rental subsidies in apartments throughout the city, meets the following criteria: (1) serves hard-to-reach homeless persons who have severe mental illness, are on the streets, and have been unwilling or unable to participate in supportive services; (2) provides 24-hour residence for an unspecified duration; (3) provides private or semiprivate accommodations; and (4) has overnight occupancy limited to 25 persons if at one site.

Supportive Services Only: Supportive Services Only projects provide services to address the special needs of the homeless person. Projects fall under this classification only if they are not providing housing to the persons receiving the services.

Outreach services can be funded as part of a housing component or as a supportive service not in conjunction with housing. Outreach provides the first point of contact for many homeless persons and families where they live on the streets.

Assessment services can be funded as part of a housing component or as a supportive service not in conjunction with housing. Assessments are done on all clients entering into service to determine the best course of assistance and which components of the Continuum of Care will best move an individual or family toward becoming housed and stable.

Although emergency housing is part of the CoC plan development required by HUD, these CoC funds will not support emergency housing (i.e., shelters). The City utilizes Emergency Shelter Grant (ESG) funding to assist in the development of emergency housing programs.

Continuum of Care 2006 Timeline

February 2006

- Public hearing to gather public testimony on the unmet needs of the homeless in Long Beach, for service providers, clients and the community.
- Correlate the results of the Choice Survey, a feedback form distributed daily at the MSC so that homeless clients can rate their top five needs for services and housing.

March 2006

- HUD release of SuperNOFA (Continuum of Care Homeless Assistance) application on March 8, 2006.
- The Homeless Services Advisory Committee (HSAC) voted at the March meeting to recommend to City Council that the Department of Health and Human Services be the lead applicant for HUD SuperNOFA funds and to oversee the Request For Proposal (RFP) process. Two sub-committees of HSAC were formed; one to conduct site visits for renewal projects and the second to participate in the broader composition of the Ad Hoc Review Committee that will review new applications and establish funding priorities for final submission to HUD.
- The HSAC membership of the Ad Hoc Review Committee meet to discuss the funding priorities to be included within the RFP and determine criteria for renewal funding.
- The composition of the Ad Hoc Review Committee is confirmed by HSAC and members identified. The composition is: three members of HSAC, one member from the Long Beach Area Coalition for the Homeless, a 10 year plan steering committee member, one member from Community Development Advisory Commission, one Long Beach Community Action Network member, one Interfaith Community Organization member, and two Board of Health and Human Services members.

April 2006

 Letter from HSAC to Mayor and City Council requesting permission for the City to be lead agency in the 2006 SuperNOFA process, and approval of the process that will be followed.

- The City's Request for Proposal (RFP) is prepared utilizing HUD's application guidelines, forms and funding priorities established by HSAC.
- Bidders' Conference will be held for agencies interested in applying with the City's consolidated application to HUD.
- Agencies receive the RFPs at the bidder's conference and, thereafter, pick up RFPs at the Health Department. Agencies will have technical assistance available to them from April 10th to April 20th.
- Agency Applications are due to the Health Department Renewals due April 21st and New Applications are due April 27th
- Send applications out to Ad Hoc Review Committee for scoring.

May 2006

- Score sheets are due back from AD Hoc Review Committee members.
- Ad Hoc Review Committee reviews RFPs and determines ranking and funding levels for inclusion in the application to HUD.
- Send out Appeal notification via email and hold an appeals hearing if needed.
- Agencies work with staff to finalize proposals.
- The application goes to print.
- The application is submitted to meet the May 25 deadline.
