DBA JAS PACIFIC, a California corporation ("Consultant"), with a place of business at 201 North Euclid Avenue, Suite A, Upland, California 91786, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34706 (the "Agreement") whereby Consultant agreed to provide as-needed plan review and inspection services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$34,500 for a total not to exceed amount of \$114,500; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add \$150,000 for a total not to exceed amount of \$264,500; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to add \$166,300 for a total not to exceed amount of \$430,800; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to add \$181,100 for a total not to exceed amount of \$611,900 and extend the term to July 31, 2020; and

WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to add \$55,100 for a total not to exceed amount of \$667,000; and

WHEREAS, the Parties desire to update the rates/charges;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. The Rates in Exhibit "B" to the Agreement are hereby amended in accordance with Exhibit "B-1", attached hereto and incorporated by this reference.
