

1 SIXTH AMENDMENT TO AGREEMENT NO. 34706

3 THIS SIXTH AMENDMENT TO AGREEMENT NO. 34706 is made and
4 entered, in duplicate, as of February 5, 2020, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on March
6 5, 2019, by and between JASON ADDISON SMITH CONSULTING SERVICES, INC. DBA
7 JAS PACIFIC, a California corporation ("Consultant"), with a place of business at 201 North
8 Euclid Avenue, Suite A, Upland, California 91786, and the CITY OF LONG BEACH, a
9 municipal corporation ("City").

10 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
11 34706 (the "Agreement") whereby Consultant agreed to provide as-needed plan review
12 and inspection services; and

13 WHEREAS, the Parties entered into a First Amendment to the Agreement to
14 add \$34,500 for a total not to exceed amount of \$114,500; and

15 WHEREAS, the Parties entered into a Second Amendment to the Agreement
16 to add \$150,000 for a total not to exceed amount of \$264,500; and

17 WHEREAS, the Parties entered into a Third Amendment to the Agreement
18 to add \$166,300 for a total not to exceed amount of \$430,800; and

19 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement
20 to add \$181,100 for a total not to exceed amount of \$611,900 and extend the term to July
21 31, 2020; and

22 WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to
23 add \$55,100 for a total not to exceed amount of \$667,000; and

24 WHEREAS, the Parties desire to update the rates/charges;

25 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
26 conditions herein contained, the Parties agree as follows:

- 27 1. The Rates in Exhibit "B" to the Agreement are hereby amended in
28 accordance with Exhibit "B-1", attached hereto and incorporated by this reference.

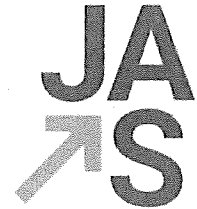
