THIS EIGHTH AMENDMENT TO AGREEMENT NO. 30976 is made and entered, in duplicate, as of January 11, 2021 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on May 19, 2020, by and between INNOVATIVE INTERFACES, INC, a California corporation ("Consultant" or "Innovative"), with a place of business at 1900 Powell Street, Suite 400, Emeryville, California 94608, and the CITY OF LONG BEACH, a municipal corporation ("City" or "Library").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with the establishment and maintenance of an automated library system; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 30976 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term one (1) additional one-year period and increase the compensation by \$166,580; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term one (1) additional three-year period and increase the compensation by \$590,343; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to extend the term one additional one-year period and increase the compensation by \$189,411; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to add additional software and increase the compensation by \$2,600; and

WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to extend the term one (1) additional one-year period, add \$198,882 to the extension, attach a revised payment schedule, and update the name of the software system; and

WHEREAS, the Parties entered into a Sixth Amendment to the Agreement to add \$4,500 for the cloud backup subscription; and

WHEREAS, the Parties entered into a Seventh Amendment to the Agreement to extend the term to December 17, 2020, add force majeure language, amend the annual compensation, and attach a revised price list; and

WHEREAS, the Parties desire to extend the term one (1) additional one year period and add \$162,366 to the extension;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 13.09 of Agreement No. 30976 is hereby amended to read as follows:

"13.09 The term of this Agreement shall commence at midnight on December 18, 2008, and shall terminate at 11:59 p.m. on December 17, 2021, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 30976 are ratified and confirmed and shall remain in full force and effect.
