FIRST AMENDMENT TO PERMIT NO. 32688

32688

THIS FIRST AMENDMENT TO PERMIT NO. 32688 is made and entered, in duplicate, as of January 1, 2014, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach ("City"), at its meeting on January 24, 2012, between STACY HINKEL, dba MOVING FORWARD FITNESS, ("Permittee") and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City granted Permittee permission to use open space within City parks for group exercise classes consisting of stroller strides training and related activities; and

WHEREAS, Permittee has requested to continue such operation under Permit No. 32688 and City is willing to permit this continued operation under this Permit;

NOW THEREFORE, in consideration of the mutual terms and conditions in Permit No. 32688, the parties agree as follows:

1. Section 2 of Permit No. 32688 is hereby deleted and amended in it's entirety as follows:

"2. TERM. The term of this Permit shall begin on January 1, 2014 and shall end on December 31, 2014. The City Manager shall have the option at his sole discretion to extend the term of this Permit for two (2), additional one (1) year periods, provided Permittee submits a written request no later than sixty (60) days prior to the expiration of the Permit year."

2. Except as expressly stated herein, all of the terms, covenants, and conditions of Permit No. 32688 are ratified and confirmed and shall remain in full force and effect.






