WHEREAS, the parties executed the First Amendment in September of 2008 to extend the term of the Agreement for one additional year; and

WHEREAS, the parties now desire to increase the Contract price by an additional Three Hundred Sixty Thousand Four Hundred Thirty-Five Dollars (\$360,435.00);

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in this Agreement, the parties agree as follows:

- 1. By this Second Amendment, the parties agree to increase the contract price by Three Hundred Sixty Thousand Four Hundred Thirty-Five Dollars (\$360,435.00) during the 4th year of this project.
- Except as expressly amended herein, all terms, covenants and conditions in Agreement No. 29391 are ratified and confirmed and shall remain in full force and effect.
