Dear Honorable Members of Long Beach City Council:

In coordination with the organizations signed on below, we write to express our strong support for the Healthcare Worker Minimum Wage. For two years, healthcare workers have been on the front lines of the COVID-19 pandemic. Workers have risked their lives, the lives of their loved ones, and in some cases paid the ultimate price in their service to our community. The psychological toll of working through the pandemic, compounded by inadequate staffing and pressure to work overtime, has caused healthcare workers to reach a breaking point.

Many healthcare workers have left healthcare and more are considering leaving soon. In a recent survey, 83% of healthcare workers reported that their departments are either severely understaffed or somewhat understaffed. Thirty-eight percent report that vacant positions in their departments take more than seven months to fill or are never filled.

Prior to the pandemic, California faced a shortage of 500,000 healthcare workers needed to care for our aging population. Now, we are facing a full-blown crisis. To retain current workers and recruit the new healthcare workers needed, we must ensure they are fairly compensated. By setting a \$25/hour minimum wage we can attract the workers we need to ensure we do not see a decline in quality of care for our families in Long Beach.

During the pandemic, healthcare corporations received billions in federal funding and tax relief and have made huge profits. Meanwhile, frontline healthcare workers have not seen an increase in compensation that matches their commitment to serving our community. Long Beach needs skilled healthcare workers. Every individual who walks through the doors of their hospital, clinic, or other healthcare facility deserves the highest quality of care.

The Healthcare Worker Minimum Wage will ensure that federal funds and corporate profits are invested in our frontline caregivers. I urge you to adopt and pass the Healthcare Minimum Wage in the city of Long Beach to ensure we address the healthcare staffing crisis and provide high quality care for our community.
