

1 SECOND AMENDMENT TO AGREEMENT NO. 32674

3 THIS SECOND AMENDMENT TO AGREEMENT NO. 32674 is made and
4 entered, in duplicate, as of October 31, 2013 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on May
6 22, 2012, by and between COMPLETE OFFICE OF CALIFORNIA, INC., a California
7 corporation ("Consultant"), with a place of business at 12724 Moore Street, Cerritos,
8 California 90703, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be
10 performed in connection with a Citywide office supply program; and

11 WHEREAS, the parties entered Agreement No. 32674 whereby Consultant
12 agreed to provide such services; and

13 WHEREAS, the parties desire to extend the term and add \$650,000;

14 NOW, THEREFORE, in consideration of the mutual terms and conditions in
15 the Agreement and in this Second Amendment, the parties agree as follows:

16 1. Section 1.A. of Agreement No. 32674 is hereby amended to read as
17 follows:

18 "1. SCOPE OF WORK OR SERVICES.

19 A. Consultant shall furnish specialized services more particularly
20 described in Exhibit "A", attached to this Agreement and incorporated by this
21 reference, in accordance with the standards of the profession, and City shall pay
22 for these services in the manner described below, not to exceed Two Million Six
23 Hundred Thousand Dollars (\$2,600,000) during the term, at the rates or charges
24 shown in Exhibit "B".

25 2. Section 2 of Agreement No. 32674 is hereby amended to read as
26 follows:

27 "2. TERM. The term of this Agreement shall commence at midnight on
28 May 29, 2012, and shall terminate at 11:59 p.m. on May 29, 2014, unless sooner

1 terminated as provided in this Agreement, or unless the services or the Project is
2 completed sooner."

3 3. Except as expressly amended in this Second Amendment, all terms
4 and conditions in Agreement No. 32674 are ratified and confirmed and shall remain in full
5 force and effect.
