## FIRST AMENDMENT TO AGREEMENT NO. 34481

## 

THIS FIRST AMENDMENT TO AGREEMENT NO. 34481 is made and entered, in duplicate, as of October 24, 2018, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on November 1, 2016, by and between LONG BEACH COMMUNITY COLLEGE DISTRICT, a public corporation ("District"), whose address is 4901 E. Carson Street, Long Beach, California 90808, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and District (the "Parties") entered into Agreement No. 34481 whereby City has agreed to process District's parking citations; and

WHEREAS, the Parties desire to extend the term and include the addition of AB503 and AB2544 program services/fees;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 3.A. of Agreement No. 34481 is hereby amended to read as follows:
  - "A. The term of this Agreement shall commence at midnight on December 27, 2016, and shall terminate at 11:59 p.m. on December 26, 2019, unless sooner terminated as provided in this Agreement, or unless the services or the project is completed sooner. The term may be extended for two (2) additional one-year terms, at the discretion of the City Manager."
    - 2. Section 2.F. is added to Agreement No. 34481 to read as follows:
  - "F. City's Processing Fees for AB503 and AB2544 services shall be five dollars (\$5.00) per request. This includes the acceptance of documentation via US mail and in-person, the review of the documentation to meet qualifications, scanning of all documentation and attachment to the citation(s) to which it applies. Based on Program rules, City will either accept or deny each request and then proceed to set up the payment plan or issue a letter of denial with a reason for the

denial. In addition, City will monitor the approved payment plans for compliance, one-time extensions or cancellation of delinquent payment plans during the timeline for completion."

 Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34481 are ratified and confirmed and shall remain in full force and effect.
