3 THIS THIRD AMENDMENT TO AGREEMENT NO. 33912 is made and
4 entered, in duplicate, as of November 6, 2018 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on June
6 2, 2015, by and between KARDENT, a California corporation ("Consultant"), with a place
7 of business at 11 Golden Shore, Suite #540, Long Beach, California 90802, and the CITY
8 OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be
10 performed in connection with as-needed architectural services; and

11 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
12 33912 (the "Agreement") whereby Consultant agreed to provide these services; and

13 WHEREAS, the Parties entered into a First Amendment to the Agreement to
14 extend the term an additional one (1) year period and add \$500,000; and

15 WHEREAS, the Parties entered into a Second Amendment to the Agreement
16 to add \$300,000 for a total not to exceed amount of \$1,200,000 and extend the term one
17 (1) additional one-year period; and

18 WHEREAS, the Parties desire to update the rates/charges to include two (2)
19 new sub-consultants;

20 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
21 conditions herein contained, the Parties agree as follows:

22 1. The Rates/Fees in Exhibit "B" attached to the Agreement is hereby
23 amended to include two (2) new subconsultants more particularly described in Exhibit "B-
24 1", attached hereto and incorporated by this reference.

25 2. Except as expressly modified herein, all of the terms and conditions
26 contained in Agreement No. 33912 are ratified and confirmed and shall remain in full force
27 and effect.




