The City Attorney has prepared the attached Resolution designating the official ballot listing of the candidates that have been nominated for the City's Special Municipal Election.





A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH DESIGNATING THE BALLOT
LISTING OF THE CANDIDATES WHICH HAVE BEEN
NOMINATED FOR THE SPECIAL MUNICIPAL ELECTION
ON TUESDAY, APRIL 7, 2009

WHEREAS, in accordance with the Long Beach City Charter the City
Council has called a special municipal election for Member of the City Council for Council
District One, to be held in the City of Long Beach Councilmanic District 1 on
April 7, 2009; and

WHEREAS, in accordance with City Charter Section 1907, the City Clerk
has submitted to the City Council a certified list of the candidates which have been duly
nominated as required by law for the elective office to be voted on at said election, and
the names are listed for each such office in the order of the randomized alphabet
selected by the Secretary of State in a drawing held on January 12, 2009, pursuant to
California Elections Code Section 13113;
