### THIRD AMENDMENT TO CONTRACT NO. 30422

## 

THIS THIRD AMENDMENT TO CONTRACT NO. 30422 is made and entered, in duplicate, as of December 8, 2009 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meetings held on December 4, 2007 and January 6, 2009, by and between SULLY-MILLER CONTRACTING COMPANY, a Delaware corporation ("Contractor"), whose address is 1100 E. Orangethorpe Avenue, Suite 200, Anaheim, California 92801, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered Contract No. 30422 whereby Contractor agreed to perform the work described in Plans & Specifications No. R-6738; and

WHEREAS, the parties desire to extend the term of the Contract;

NOW, THEREFORE, in consideration of the mutual terms and conditions herein contained, the parties agree as follows:

- 1. Section 4 of Contract No. 30422 is hereby amended in its entirety to read as follows:
- "4. <u>TIME FOR CONTRACT</u>. Contractor shall commence work on a date to be specified in a written "Notice to Proceed" from City and shall complete all work within Three Hundred Sixty-Five (365) calendar days thereafter, subject to strikes, lockouts and events beyond the control of Contractor. To the extent all work is not completed within three hundred sixty-five (365) days after the date specified in the Notice to Proceed, the term of the Contract shall be extended and, unless sooner terminated as provided in this Contract, or unless the work to be performed hereunder is completed sooner, shall terminate at 11:59 p.m. on March 31, 2010. Time is of the essence hereunder. City will suffer damage if the work is not completed within the time stated, but those damages would be difficult or impractical to determine. So, Contractor shall pay to City, as liquidated damages, the amount stated in the Contract Documents."
  - 2. Except as expressly modified herein, all of the terms and conditions

contained in Contract No. 30422 are ratified	d and confirmed and shall remain in full force
and effect.
