WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34489 (the "Agreement") whereby Consultant agreed to provide as-needed construction materials testing and inspection services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$2,000,000 for a total not to exceed amount of \$4,000,000 and extend the term to December 31, 2020; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to December 31, 2021; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to attach an updated rate sheet; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM.</u> The term of this Agreement shall commence at midnight on January 1, 2017, and shall terminate at 11:59 p.m. on December 31, 2022, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
