

1 FIRST AMENDMENT TO AGREEMENT NO. 33914

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 33914 is made and  
4 entered, in duplicate, as of June 12, 2017 for reference purposes only, pursuant to a minute  
5 order adopted by the City Council of the City of Long Beach at its meeting on June 2, 2015,  
6 by and between GWYNNE PUGH URBAN STUDIO INC., a California corporation  
7 ("Consultant"), with a place of business at 2800 28th Street, Suite 171, Santa Monica,  
8 California 90405, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be  
10 performed in connection with as-needed architectural services; and

11 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.  
12 33914 (the "Agreement") whereby Consultant agreed to provide these services; and

13 WHEREAS, the Parties desire to extend the term an additional one (1) year  
14 period and add \$100,000;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
16 conditions herein contained, the Parties agree as follows:

17 1. Section 1.A. of the Agreement is hereby amended to read as follows:

18 "A. Consultant shall furnish specialized services more particularly  
19 described in Exhibit "A", attached to this Agreement and incorporated by this  
20 reference, in accordance with the standards of the profession, and City shall pay for  
21 these services in the manner described below, not to exceed Six Hundred Thousand  
22 Dollars (\$600,000), at the rates or charges shown in Exhibit "B"."

23 2. Section 2 of the Agreement is hereby amended to read as follows:

24 "2. TERM. The term of this Agreement shall commence at midnight on  
25 July 20, 2015, and shall terminate at 11:59 p.m. on July 19, 2018, unless sooner terminated  
26 as provided in this Agreement, or unless the services or the Project is completed sooner.  
27 The Parties have the option to extend the term for two (2) additional one-year periods."

28 3. Except as expressly modified herein, all of the terms and conditions
