- On November 6, 2018, voters approved Measure CCC
- Powers and Duties
 - Responsible for the impartial and effective administration and implementation of the provisions of the Charter, statutes and ordinances concerning campaign finance, lobbying, conflicts of interest and governmental ethics.
- Recommending body
- Seven-member Commission
 - Two members appointed by the Mayor
 - Two members appointed by the City Auditor
 - Remaining three members are appointed by the Commission
