A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AWARDING A CONTRACT TO KINNETIC LABORATORIES, INC., WITHOUT ADVERTISING FOR BIDS, IN AN AMOUNT NOT TO EXCEED \$362,392 IN TIDELANDS FUNDS FOR BACTERIAL TESTING AT COASTAL BEACH SITES ON AN URGENT BASIS

WHEREAS, the Charter of the City of Long Beach (the "City"), Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City desires to purchase consultant services to perform water quality testing and bacterial monitoring at selected coastal sites in order to address the level and sources of fecal contamination in recreation areas; and

WHEREAS, public health concerns associated with beach water contamination have created an urgent need for these testing services; and

WHEREAS, these public health concerns render it an immediate necessity to enter into a contract as soon as possible and make it impracticable to conduct a formal competitive process for the selection of a contractor;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

1. The above recitals are true and correct and are incorporated herein by this reference.
2. The City Manager of the City is hereby authorized to enter into an agreement with Kinnetic Laboratories, Inc. in an amount not to exceed \$362,392 for


1 water quality monitoring and bacterial testing at coastal sites in the City of Long Beach
