A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO SUBMIT AN APPLICATION FOR AND TO ENTER AN AGREEMENT AND ALL AMENDMENTS WITH THE STATE DEPARTMENT OF PARKS AND RECREATION FOR FUNDING UNDER THE RECREATIONAL TRAILS PROGRAM FOR THE SAN GABRIEL RIVER WEST TRAIL PROJECT

WHEREAS, the State of California provides grants to public entities under the Transportational Equity Act for the 21st Century ("Act"); and

WHEREAS, the State Department of Parks and Recreation ("State") has the responsibility for administration of the grant program; and

WHEREAS, the State requires that the applicant for grant funds approve submission of the application by resolution; and

WHEREAS, if a grant is given to the applicant, the applicant must enter an agreement with the State relating to the grant program;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. That the City Manager of the City of Long Beach is hereby authorized to submit an application for grant funds for the development of a multi-use trail adjacent to the westerly portion of the San Gabriel River (the "San Gabriel River West Trail Project" or "Project").

Sec. 2. The City Manager is hereby authorized and appointed to conduct all negotiations and execute and submit all documents including but not limited to applications, agreements, amendments, payments requests, and other documents which may be necessary to complete the Project with grant funds.
