DISCUSSION

Pursuant to your request, attached are the following resolutions for consolidation of the Initiative with the State General Election to be held on Tuesday, November 6, 2012:

1. A Resolution of the City Council of the City of Long Beach Requesting Board of Supervisors of the County of Los Angeles to Authorize and Order the Consolidation of a Citywide Special Municipal Election with the Statewide General Election to be Held November 6, 2012, and Determining and Declaring the City Will Pay to the County Reasonable and Actual Expenses Incurred by the County on Account of the Consolidation of this Election; and
3. A Resolution of the City Council of the City of Long Beach Requesting the Board of Supervisors of the County of Los Angeles to Render Specified Services to the City Relating to the Conduct of a Special Municipal Election to be Held on Tuesday, November 6, 2012.

A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH, CALIFORNIA, REQUESTING THE
BOARD OF SUPERVISORS OF THE COUNTY OF LOS
ANGELES TO RENDER SPECIFIED SERVICES TO THE
CITY RELATING TO THE CONDUCT OF A SPECIAL
MUNICIPAL ELECTION TO BE HELD ON TUESDAY,
NOVEMBER 6, 2012

WHEREAS, a Special Municipal Election is to be held in the City of Long Beach, California on November 6, 2012; and

WHEREAS, in the course of conduct of these elections, it may be necessary to mail sample ballots and polling place information to the registered voters of the City, and it will facilitate such mailing if the Registrar-Recorder/County Clerk of the County of Los Angeles will make available to the City the computer record of the names and addresses of all eligible registered voters in order that labels may be printed for attaching to self-mailer sample ballot pamphlets; and

WHEREAS, all necessary expenses in performing this service shall be paid by the City of Long Beach.

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. That pursuant to the provisions of Section 10002 of the Elections Code of the State of California, the City Council requests the Board of Supervisors of the County to permit the Registrar-Recorder/County Clerk to provide all services necessary for the lawful and effective conduct of the special election to be held on November 6, 2012, and make available to the City additional assistance according to state law.

1 Section 2. That the City shall reimburse the County for services
2 performed when the work is completed and upon presentation to the City of a properly
3 approved bill.
