1 SECOND AMENDMENT TO AGREEMENT NO. 32946

3 THIS SECOND AMENDMENT TO AGREEMENT NO. 32946 is made and  
4 entered, pursuant to a minute order adopted by the City Council of the City of Long  
5 Beach at its meeting held on November 13, 2012, by and between FORENSIC  
6 NURSING SPECIALISTS, INC., doing business as FORENSIC NURSE SPECIALISTS,  
7 with a place of business at 3373 Cerritos Avenue, Los Alamitos, California 90720,  
8 ("Contractor"), and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the parties entered Agreement No. 32946 whereby Contractor  
10 agreed to provide medical examinations, evidence collection, and appropriate treatment  
11 to victims of sexual assault; and

12 WHEREAS, the parties executed the First Amendment to Agreement No.  
13 32946 on November 12, 2013 to extend the term of the Agreement; and

14 WHEREAS, now the parties desire to further extend the term of the  
15 Agreement;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants and  
17 conditions herein, the parties agree as follows:

18 1. Section 2 of Agreement No. 32946 is hereby amended in its entirety  
19 to read as follows:

20 "2. The term of this Agreement shall commence on November 1, 2014  
21 and shall terminate on October 30, 2015."

22 2. Section 4 of Agreement No. 32946 is hereby amended in its entirety  
23 to read as follows:

24 "4. City shall pay Contractor hereunder in due course of payments of the  
25 City following the end of each calendar month and receipt from Contractor of invoices  
26 therefore, covering said services performed during said month for which payment has not  
27 heretofore been made by City to Contractor, with the following stipulation: In order for the  
28 City to maintain necessary cost accounting controls, all invoices covering said services

1 must be submitted within thirty (30) days after the end of the month in which services  
2 were performed. Any invoices submitted after this time period will not be paid by the City.  
3 The total compensation to be paid during the period from November 1, 2014 through  
4 October 30, 2015 shall not exceed One Hundred Twenty Thousand Dollars  
5 (\$120,000.00).”

6                   3.       Except as expressly stated herein, all of the terms, covenants, and  
7 conditions of Agreement No. 32946 are ratified and confirmed and shall remain in full  
8 force and effect.

**Contractor Fee Schedule**

<u>Item or Service Provided</u>	<u>Cost Per Unit</u>
Victim sexual assault examinations evidence collection and treatment (1)	\$700.00
VAWA abbreviated sexual assault examinations evidence collection and treatment	\$300.00
Suspect sexual assault examinations and evidence collection	\$350.00
Follow-up examination	\$100.00
Expert witness testimony (2)	\$350.00
Touch DNA examinations / swabs (3)	\$375.00
Non-acute child exam	\$500.00

(1) Sexual assault examinations include ANY call out response requested of the Sexual Assault Nurse Examiner by the Long Beach Police Department.

(2) Expert witness testimony will be billed at \$100.00 per hour, to a maximum daily limit of \$350.00 per day per case.

(3) This is a pilot program. After the first five examinations, the cost will be negotiated and mutually agreed on by Forensic Nurse Specialists, Inc. and City of Long Beach Police Department.
