WHEREAS, City requires specialized services requiring unique skills to be performed in connection with an Electronic Plan Check System; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34211 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to revise the scope of services and extend the term to February 28, 2018; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to February 28, 2019; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to extend the term to February 28, 2020; and

WHEREAS, the Parties desire to extend the term one (1) additional oneyear period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on March 1, 2016, and shall terminate at 11:59 p.m. on February 28, 2021, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
