Air Taxi – Aircraft that provide public transportation of persons and/or property on-demand.

General Aviation – Aviation activity other than scheduled air carriers flights, flights by industrial operators or by charter and flights by public aircraft

Air Cargo – Cargo carried by aircraft, both inbound and outbound.

Background

- **The purpose of this report is to provide the Long Beach Mayor and City Council with a summary of the Airport Advisory Commission (AAC) activities during the reporting period January 2005 – December 2005.**
- **Its purpose is also to provide recommendations regarding the Commission's future operation, pursuant to Section 2.18.090(9) of the Long Beach Municipal Code**

Commission Role

- **Pursuant to City Code, the role of the Airport Advisory Commission is to:**
 - **Consult with and advise the City Council in formulating City policies regarding the development and operation of the Long Beach Airport.**
 - **Study and analyze, for the purpose of evaluation and recommendation of policy, issues which have been referred to it by the City Council. This may include, among other topics, rates/fees, lease and land use policies, standards of service, facility requirements, and environmental standards.**

Officers and Committees

- **During the reporting period, Alan Fox has been Chair, and Ron Salk has been Vice Chair.**
- **Committees and member functional assignments throughout the reporting period have been as follows:**
 - **Business Outreach Committee**
 - **Community Outreach Committee**
 - **Protocol/Ethics Committee**
 - **Leasing/Land Use/Minimum Standards Committee**
 - **Aviation Noise Abatement Committee Liaison**
 - **Long Beach Airport Association/Airport Area Business Council Liaison**
 - **Special Events Liaison**
 - **City Council Member Liaison (each AAC member assigned to be liaison with a Council member's or the Mayor's office)**

Meetings

- **During the reporting period, the Commission held ten regular meetings (no meeting in July or December). Eight of the meetings were held at the SKYLINKS Golf Course Clubhouse public meeting room, one was held at the Airport tenant Mercury Air Center's meeting room, and one was held at the Airport tenant FlightSafety International's meeting room.**
- **All meetings were duly noticed and open to the public.**
- **Approved minutes of all meetings have been forwarded to the Mayor and City Council for their information and files (note: minutes for the November meeting are expected to be forwarded during the January timeframe, because no meeting was held in December and as such, November minutes were not reviewed/approved in December).**

Considerations, Efforts, and Actions During the Reporting Period

- **All Commissioners filed Statements of Economic Interest, as required under State law.**
- **The Commission received non-confidential City Attorney's Office advisories regarding provisions of the Brown Act.**
- **The Commission received reports and briefings, and gave input regarding, leasing and property management issues, including Parcel X development and the Terminal Concessions RFP.**
- **The Commission continued its Airport tenant business outreach efforts, including conducting scheduled public**

Considerations, Efforts and Actions During the Reporting Period (Cont)

meetings at new tenant Mercury Air Center, and long time tenant FlightSafety International pilot training center. The Commission also received briefings by the Airport's new Terminal concession operators, regarding future service and facility upgrades.

- The Commission reviewed the Airport's 2005 Airport Business Focus Elements document.**
- The Commission received briefings and commented on the City-wide Human Health Risk Assessment conducted by the Health and Human Services Department, and the Airport Economic Impact Study conducted by the Community Development Department.**

Considerations, Efforts and Actions During the Reporting Period (Cont)

- **The Commission received briefings and had discussions about issues being addressed by the tenant-based Aviation Noise Abatement Committee, including late night airline activity.**
- **The Commission received briefings on the Annual Airline Noise Budget Report, and on the background/history of the City's aircraft noise limits and noise monitor locations.**
- **The Commission had briefings and discussions about the Airport's emergency response drills, general aviation security plans, and emergency responses to specific incidents.**

Considerations, Efforts and Actions During the Reporting Period (Cont)

- **The Commission has discussed potential changes in its normal monthly meeting protocol.**
- **The Commission has been briefed by City Manager's Office representatives regarding the City's multi-year budget plan.**
- **The Commission was addressed by Mayor Beverly O'Neill, thanking Commission members and staff for their efforts toward formulating Terminal Improvement project recommendations, and advising the Commission that they need not provide formal input regarding the Terminal Improvements Draft EIR.**

Recommendations

- **Your Airport Advisory Commission appreciates the opportunity to serve the citizens of Long Beach. The Airport is an important part of Long Beach, from an historic standpoint as well as the current and future air transportation of its residents and the accompanying economic benefits to the City. It is also important that the Airport maintain its compatibility with the surrounding community, in fulfillment of the City's 2010 Strategic Plan. The Commission sees ongoing benefits from its continuing involvement in fulfillment of its mission as prescribed by City Code.**
- **As it has in the past, the Commission will continue to interface with the Mayor and Council members, and to share its views and what it has learned. We encourage your Honorable Mayor and City Council to rely on our resources of knowledge and inter-organizational contacts, including through the referral of issues.**

Recommendations (cont)

- **The Commission looks forward to working with the City and its representatives over the coming year(s), and hopes to continue to actively engage the public through our outreach efforts, including Airport users, on issues such as minimum standards, land use/development requirements, environmental regulations, and special events.**
- **The 2010 Strategic Plan Airport components, including regional aviation issues and Airport land use issues, should require active monitoring and review, and probable Commission involvement in the future.**

Commission Staff Support and Related Costs

- **Out of pocket costs incurred by the Airport Enterprise Fund for Commission support are limited to those expended for refreshments and sometimes room rental at scheduled public meetings, an amount estimated to be \$1,000 for calendar year 2005.**
