

1 FIRST AMENDMENT TO AGREEMENT NO. 34492

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 34492 is made and  
4 entered, in duplicate, as of November 13, 2018, for reference purposes only, pursuant to  
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on  
6 December 20, 2016, by and between GROUP DELTA CONSULTANTS, INC., a California  
7 corporation ("Consultant"), with a place of business at 370 Amapole Avenue, Suite 212,  
8 Torrance, California 90501, and the CITY OF LONG BEACH, a municipal corporation  
9 ("City").

10 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.  
11 34492 whereby Consultant agreed to provide as-needed construction materials testing and  
12 inspection services; and

13 WHEREAS, the Parties desire to add \$2,000,000 to the Agreement for a total  
14 not to exceed amount of \$3,000,000;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
16 conditions herein contained, the Parties agree as follows:

17 1. Section 1.A. of Agreement No. 34492 is hereby amended to read as  
18 follows:

19 "A. Consultant shall furnish specialized services more particularly  
20 described in Exhibit "A", attached to this Agreement and incorporated by this  
21 reference, in accordance with the standards of the profession, and City shall pay for  
22 these services in the manner described below, not to exceed Three Million Dollars  
23 (\$3,000,000), at the rates or charges shown in Exhibit "B".

24 2. Except as expressly amended herein, all terms and conditions in  
25 Agreement No. 34492 are ratified and confirmed and shall remain in full force and effect.
