## THIRD AMENDMENT TO AGREEMENT NO. 35189

THIS THIRD AMENDMENT TO AGREEMENT NO. 35189 is made and entered, in duplicate, as of October 22, 2021, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on August 21, 2018, by and between LEE & ASSOCIATES COMMERCIAL REAL ESTATE SERVICES, INC. – SOUTH BAY, a California corporation ("Consultant"), with a place of business at 1411 W. 190<sup>th</sup> Street, Suite 450, Gardena, California 90248, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35189 (the "Agreement") whereby Consultant agreed to provide as-needed real estate broker services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$25,000 for a total not to exceed amount of \$55,000 and extend the term to June 30, 2021; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add \$20,000 for a total not to exceed amount of \$75,000 and extend the term to June 30, 2022; and

WHEREAS, the Parties desire to add \$100,000 to the Agreement;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A. of the Agreement is hereby amended to read as follows:
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed One Hundred Seventy-Five Thousand Dollars (\$175,000), at the rates or charges shown in Exhibit "B"."
