Adopt Specifications WD-11-22 and authorize the General Manager to execute an agreement with DuBois Chemicals Inc., to furnish and deliver Hydrofluosilicic Acid (23% by weight basis) in an amount not to exceed \$25,150 for a period of six months.

Executive Summary

Bids for Specification WD-11-22 to furnish and deliver Hydrofluosilicic Acid, a water treatment chemical used at Long Beach Ground Water Treatment Plant, were opened on December 3, 2021. One bid was received from DuBois Chemicals Inc. DuBois Chemicals, Inc. is the current supplier of Hydrofluosilicic Acid to LBWD and is meeting performance specifications.

Recommendation

Adopt Specifications WD-11-22 and authorize the General Manager to execute an agreement with DuBois Chemicals Inc., to furnish and deliver Hydrofluosilicic Acid (23% by weight basis) in an amount not to exceed \$25,150 for a period of six months.

Fiscal Impact: The cost to the Water Fund will be incurred during FY22, with the actual amounts unknown at this time but the total amount will not exceed the contract total of \$25,150 for the contract term. These costs are included in the FY22 budget.
