- In October 2021, the Board:
 - Adopted Specifications WD-15-19 for North LB Collection Main Control Valve Upgrade Project (EO-3435)
 - Authorized General Manager to execute contract with Cora Constructors, Inc. for \$1,249,350.



Executive Summary (Cont.)

- In November 2021, the General Manager executed contract with Cora to:
 - Rehabilitate existing pressure transmitter vault located south of the intersection of Cherry Avenue and Tehachapi Drive
 - Construct new vault for the new butterfly valve, approximately 1,500 feet east of the intersection of Cherry Avenue and Wardlow Road
 - pressure transmitter existing valve • Upgrade and control appurtenances
 - Assess condition of North LB collection main



Executive Summary (Cont.)

• In December 2021, Cora:

• Requested 6,000 sq. ft. of space at St. Louis Avenue and 32nd Street to store containers, vehicles, equipment, tools, and materials necessary for construction services related to North LB Collection Main Control Valve Upgrade Project (EO-3435).




Fiscal Impact

- Monthly rental of rate of \$1,260 based on 2019 appraisal.
- Revenue to Water Fund
 - FY 22 \$7,560 for 6-month period
 - FY 22 \$10,080 and FY 23 \$5,040 with 6-month extended period
- LBWD would be released from liability in the event of loss or damage of Cora's property or that of their representatives
- Rent prorated if vacating property early
