THIS SECOND AMENDMENT TO AGREEMENT NO. 35780 is made and entered, in duplicate, as of January 19, 2022, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on November 17, 2020, by and between PADILLA & ASSOCIATES, INC., a California corporation ("Consultant"), with a place of business at 211 E. City Place Drive, Santa Ana, California 92705, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35780 (the "Agreement") whereby Consultant agreed to provide labor compliance monitoring services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to increase the annual contract amount by \$50,000 for a total annual not to exceed amount of \$100,000; and

WHEREAS, the Parties desire to update Exhibit "B" to the Agreement to add one (1) additional Compliance Officer;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Exhibit "B" to the Agreement is hereby amended to include one (1) additional Compliance Officer, attached hereto and incorporated herein as Exhibit "B-1".

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35780 are ratified and confirmed and shall remain in full force and effect.
