# City Council Direction on CPCC Evaluation

- Independent evaluation of CPCC conducted May 2021 – January 2022
- Community Engagement
  - Stakeholder Interviews
  - Listening/Feedback Meetings
  - Community Survey
- Final evaluation report presented to the City Council on February 15, 2022
- City Council directed City staff to begin the Charter Amendment process; and,
- Implement the interim CPCC improvements recommended in the Evaluation Report

## **City Charter Amendment Process**

#### **City Attorney Prepared Draft Amended Charter Language**

Amend and restate Article XIA of the City Charter to establish a Director of Police Oversight and a restructured Police Oversight Commission

#### **Meet and Confer (Phase I)**

Staff completed the Meet and Confer process with impacted labor associations regarding Charter Amendment language to restructure the CPCC process

#### **City Council referral to Charter Amendment Committee**

City Council referred the proposed Amendment to the Charter Amendment Committee



## **CPCC Charter Amendment Changes**

## If approved by voters, the Charter Amendment would:

- Appoint a Police Oversight Director
- Establish a Police Oversight Commission
- Amend the number of members and term of the Police Oversight Commission (to be consistent with other City Charter Commissions)
- Require adoption of Municipal Code provisions for administrative and management functions of the Director and Commission
- Require City Council authorization of a budget to conduct the functions and duties of the Director and Commission.
- Trigger Phase 2 meet and confer with affected labor associations regarding workplace impacts



## **CPCC Oversight**

### If the Charter Amendment is not approved by voters:

- Current CPCC structure remains in place:
  - No change in Commission name, number of Commissioners, terms of office
  - City Manager staff continues to provide CPCC oversight function
  - Charter language / Commission authority remains the same
- City staff will continue to implement interim recommendations proposed from the CPCC evaluation to improve CPCC operations and address issues such as efficiency, transparency of operations, staffing, training, and on-line accessibility

Public notice of second Charter Amendment Committee meeting	June 28

City Council consideration of Charter Amendments for Nov 2022 ballot	August 9
Election Date	November 8
