At the time, Republicans were driving up the score in red states by campaigning against gay marriage and gays in the military. They also promoted abstinence-only education and my high school sex ed included a section that could be summarized as "if you're gay, you're probably going to die from AIDS." For a decade after high school, I felt shame, guilt, and fear every single time I had sex with another man. I got tested regularly and I any time I got sick- a cold, flu, allergies- I was sure it was HIV. Then came PrEP, a daily pill that's 99% EFFECTIVE at preventing infection. Used in combination with condoms and antiretroviral therapy, it almost completely eliminates the spread of HIV. PrEP freed me from the constant worry and fear of my own sexuality.
