3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING CITY MANAGER,
5 OR DESIGNEE, TO SUBMIT A GRANT APPLICATION
6 TO THE STRATEGIC GROWTH COUNCIL THROUGH
7 THE TRANSFORMATIVE CLIMATE COMMUNITIES
8 PLANNING GRANT PROGRAM, IN AN AMOUNT NOT
9 TO EXCEED \$300,000.00 TO DEVELOP A CAAP
10 IMPLEMENTATION PLAN; IF AWARDED, ACCEPT AN
11 AMOUNT UP TO \$300,000.00 FOR THE COMPLETION
12 OF THE CAAP IMPLEMENTATION PLAN; AND,
13 EXECUTE ALL DOCUMENTS NECESSARY TO ACCEPT
14 THE FUNDS AND IMPLEMENT THE PROJECT

16 WHEREAS, the Legislature and Governor of the State of California have
17 provided funds for the Transformative Climates Communities Program in partnership with
18 the California Department of Conservation (Planning Grant); and

19 WHEREAS, the Strategic Growth Council has been delegated the
20 responsibility for the administration of this grant program, including developing guidelines
21 and selection criteria; and

22 WHEREAS, said procedures established by the Strategic Growth Council
23 require a resolution that identifies the lead applicant, authorizes the lead applicant to apply
24 for and if awarded accept the Planning Grant, and execute all related documents; and

25 WHEREAS, the deadline to submit a Planning Grant application for the fourth
26 cycle is July 1, 2022;

27 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
28 follows:

1 Section 1. The above recitals are true and correct and are incorporated
2 herein.

3 Section 2. Approves the City of Long Beach to serve as the lead applicant
4 for the Planning Grant application due by July 1, 2022.

5 Section 3. Authorizes the City of Long Beach to apply for and if
6 awarded accept the Planning Grant.

7 Section 4. Appoints the City Manager, or designee, as agent to conduct
8 all negotiations, execute and submit all documents including, but not limited to,
9 applications, agreements, and payment requests related to the Planning Grant.

10 Section 5. This resolution shall take effect immediately upon its adoption
11 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
