THIS FIRST AMENDMENT TO AGREEMENT NO. 35671 is made and 3 entered, in duplicate, as of May 31, 2022 for reference purposes only, pursuant to 4 Resolution No. RES-20-0097 adopted by the City Council of the City of Long Beach at its 5 meetings on August 11, 2020 and additional funding authority provided by the City Council on May 24, 2022, by and between W.W. GRAINGER, INC., an Illinois corporation ("Contractor"), whose address is 100 Grainger Parkway, Lake Forest, IL 60045, and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 35671 (the "Agreement") to purchase maintenance, repair, and operations supplies and related materials for a wide range of fieldwork needs; and

WHEREAS, the Parties desire to increase the annual amount by \$300,000 with a twenty percent contingency in the amount of \$60,000, for a revised total agreement amount not to exceed \$1,560,000;

NOW, THEREFORE, in consideration of the terms and conditions herein 16 contained, the Parties agree as follows: 17

> Section 1.B. of the Agreement is hereby amended to read as follows: 1.

Contractor shall sell, furnish and deliver to the City "В. maintenance, repair, and operations supplies and related materials of substantially the same type and kind purchased under the Tucson Contract, as modified by Exhibit "B" attached to the Agreement and incorporated by this reference, in an annual amount not to exceed One Million Three Hundred Thousand Dollars (\$1,300,000), with a twenty percent (20%) contingency of Two Hundred Sixty Thousand Dollars (\$260,000), for a total annual amount not to exceed One Million Five Hundred Sixty Thousand Dollars (\$1,560,000) including tax and fees. To the extent that the Tucson Contract and this Agreement are inconsistent, the following priority shall govern: (1) this Agreement and (2) the Tucson Contract."
