Adopt Specification WD-44-22 and authorize the General Manager to execute an agreement with Haaker Equipment Company to furnish and deliver hydraulic cleaning tools, miscellaneous equipment, and repair services to the Long Beach Water Department in an amount not to exceed \$90,000 for a one-year period, and to exercise the option to renew for two additional one-year periods subject to a maximum increase of 10% for each renewal period.

Executive Summary

Bids for Specification WD-44-22 to furnish and deliver hydraulic cleaning tools, miscellaneous equipment, and repair services were opened on June 21, 2022. Three bids were received and evaluated. Haaker Equipment Company was deemed to be the lowest responsive bidder and the bid document conformed to all specification requirements.

Recommendation

Adopt Specification WD-44-22 and authorize the General Manager to execute an agreement with Haaker Equipment Company to furnish and deliver hydraulic cleaning tools, miscellaneous equipment, and repair services to the Long Beach Water Department in an amount not to exceed \$90,000 for a one-year period, and to exercise the option to renew for two additional one-year periods subject to a maximum increase of 10% for each renewal period.

Fiscal Impact: The total FY 22 cost of the contract to the Sewer Fund will not exceed \$90,000. These costs are included in the Sewer Fund FY 22 Budget and financial projections.
