The City Council hereby finds this action is categorically exempt under the California Environmental Quality Act (CEQA) and finds that the proposed change will not categorically affect the character, livability or appropriate development of the surrounding area and that the proposed change is consistent with the goals, objectives and provisions of the General Plan, the official Use District Map of the City of Long Beach, as established and amended, is further amended by amending portions of Part 14 to change the zoning district to the following park from its existing zoning district to the Park (P) zoning district:

21	 Rezone from Single Family Residential (R- 1-N) to Park (P)

The portion of Part 14 of said Map that is amended by this Section 2. 24 ordinance is depicted on Exhibit "A" which map is attached hereto and by this reference 25 made a part of this ordinance and the official Use District Map of the City.

All ordinances and parts of ordinances in conflict herewith are Section 3. 27 hereby repealed. 28


