The plans and drawings for the proposed warehouse at 5860 Paramount Blvd are impressive and offer a street view devoid of the current chain link fences, storage tanks, and nondescript, sterile warehouses. The 2000 page notice of exemption I'm sure is a great read, but tough to truly evaluate in a couple of days. The parts I do see offer evidence of the need for an EIR to truly understand the scope of the contaminants, allow proper mitigation, and show the real impacts on a pollution burdened and disadvantaged neighborhood.

For all of the work and talk on equity, environmental justice, will of the people zoning (UPLAN for example), LUE green zones (not parks) and green businesses; How do projects like this get basically greenlighted for approval with such short notice for community engagement and review? Why do projects that seem to be in the planning stages for years, seem to fly under the radar until close to getting approval? Why are projects judged as CEQA exempt being built in Long Beach in the most polluted neighborhoods in California? How is this community serving in any way? The site has been in heavy industrial use since the 1930's. What is the groundwater and soil telling us? If you can't drink it or play in it, then it's unsafe.

The AUP and Conditions for Approval by definition make this project discretionary and therefore subject to CEQA review. Please deny the application at this time and call for an EIR/CEQA review to show proper consideration to our pollution burdened communities and the people of Long Beach
