RECOMMENDATION:

Recommendation to approve the placement of a Tribute Bench to honor Elizabeth Muñoz at Shoreline Aquatic Park. (District 1)

DISCUSSION

The Department of Parks, Recreation and Marine (PRM), with the consent of the City Manager, has a policy on donating funds for minor park assets, including Tribute Benches and trees. The program provides an opportunity for residents to honor and recognize those close to them who have passed away by placing a personalized Tribute bench at a city park site.

Proposed locations for new or replacement benches in Tidelands PRM-managed areas will be presented to the Marine Advisory Commission (Attachment A). This provides a public forum for residents or other interested parties to comment on all newly proposed benches or replacement bench locations and determine a timeframe for installation. Following this recommendation, installation of the bench will be the responsibility of PRM staff. PRM does not warrant benches against vandalism or destruction and based on the condition of the bench after ten (10) years, a specific bench may be removed if deemed necessary, with the location being made available unless the original party makes an additional donation in the amount in effect at that time. PRM staff has reviewed and approved the requested bench location at Shoreline Aquatic Park (Attachment B).

FISCAL IMPACT

The program raises funds to support Partners of Parks, a 501 (C) 3, whose mission is to support Long Beach Parks, Recreation and Marine programs. Proceeds from the donation cover the full cost of the bench, allocate funds to support maintenance such as annual paint touch up and provide funds to support POP's scholarship program.

SUGGESTED ACTION:

Approve recommendation.





[Elizabeth Munoz, the youngest sister of 5 siblings passed in April 2022 after a very short battle with cancer. She obtained a BA in Psychology with a minor in Applied Developmental Psychology from UCLA and a Masters in Social Work from Cal State Long Beach. Her life was dedicated to giving back to her community, particularly Long Beach, the city she loved and always returned to.](#)

[During her 26 year too short career, Liz worked as a Social Worker, a Mental Health Clinician, a Counselor, and a Therapist \(with LA County and independently\). She worked with the mentally ill, the displaced, preschoolers, autistic children, the homeless, victims of crime and anyone she found that needed help. Liz was an avid mentor to anyone in her field who needed guidance as well as a promoter of mental health to anyone who would listen. At the start of COVID, Liz was at the front line with the homeless community.](#)

[Liz did not have an accomplishment that made the National News Headlines, her accomplishment was how she lived her life and all the silent contributions she made to all she touched. The youngest of 5, she was 1st generation Mexican immigrant, Liz paved her own path with minimal support from laborer parents who had no knowledge of how to succeed in the US. She left home at 18 for UCLA and has been on her own and giving ever since. With the exception of 3 years she spent in Northern California, Liz dedicated her career to helping people the Los Angeles county with Long Beach as her home for over 20 years.](#)

[Why a bench for a relatively unknown person? Because she was more known than we were aware of. When she found out she had cancer, her friends set up a "GoFundMe" account which received in excess of \\$55,000 from 100+ people within 2 weeks. In addition, people we thought were "just acquaintances" sent her in excess of \\$25,000 directly. In cleaning her home, we found a box full of thank you letters and notes from the people she had helped as well as from parents whose children she helped. The things called out ranged from helping someone through a hard decision, through helping teenagers through suicidal ideations. Liz chose to be cremated and we would like to leave a "headstone" for the people she touched to be able to visit her.](#)
