17	provided the lowest responsive quote for each applicable site which provides the best			
18	value for as-needed security system, and related services; and			
19	WHEREAS, SSD's most recent contract with the City has expired, and in			
20	the interim of City developing a competitive solicitation for security system services at its			
21	facilities to obtain the best pricing and receive consistent services, City desires to execute			
22	an agreement with SSD to continue alarm monitoring, services, and notifications;			
23	NOW, THEREFORE, the City Council of the City of Long Beach resolves as			
24	follows:			
25	Section 1. The above recitals are true and correct and are incorporated			
26	herein by this reference.			
27	Section 2. The City Manager or designee is hereby authorized to enter a			
28	contract with Security Signal Devices, Inc. for the security systems services at several

2	option to renew the contract, at the discretion of the City Manager.
